LearnWell Instruction Services

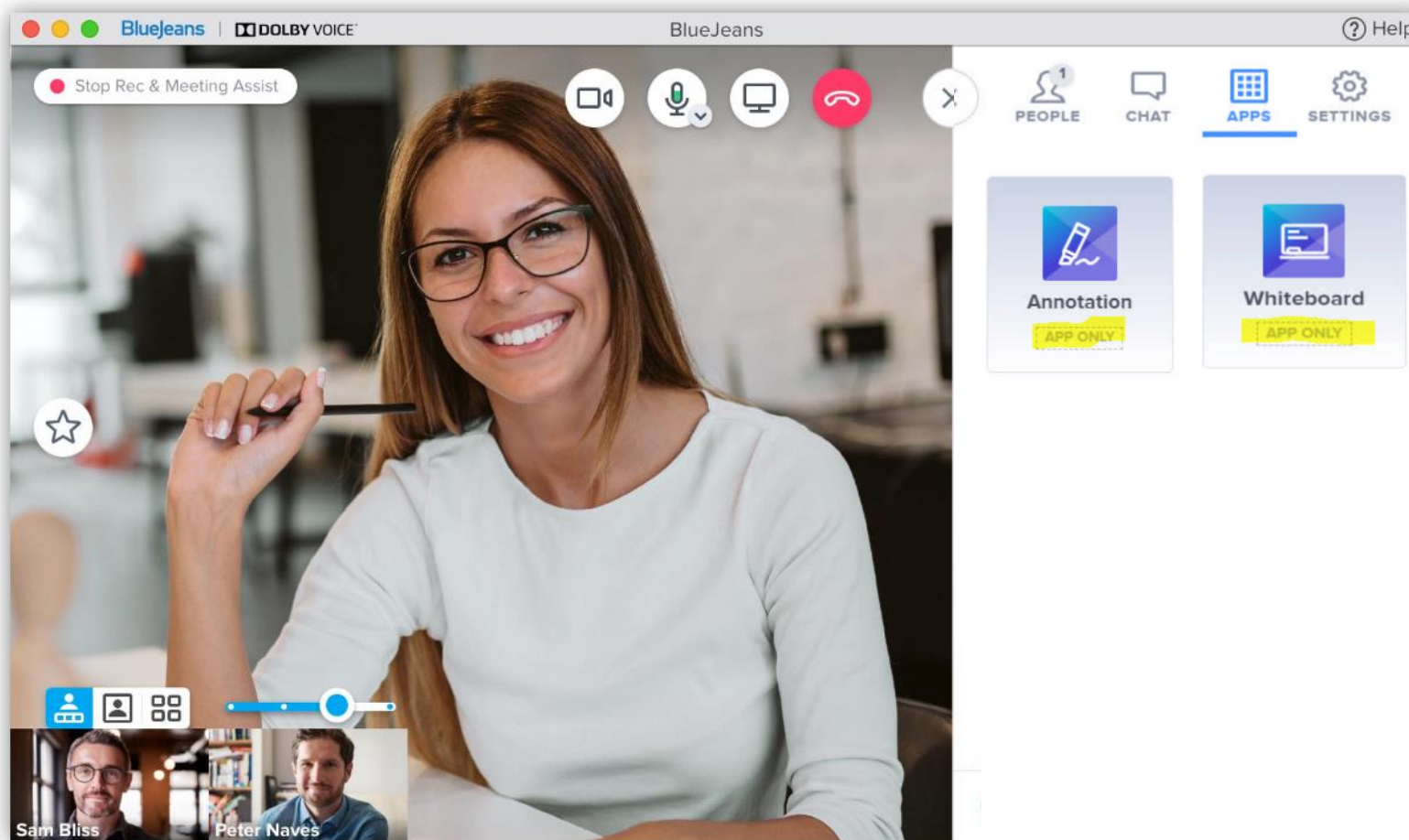
- In response to the COVID-19 crisis, LearnWell has developed alternative instructional methods to continue supporting academic progress for patients at your hospital.
- These services are an adaptation of LearnWell's existing one-on-one virtual teaching for homebound and hospitalized students.
- Instructional alternatives include:
 - Behavioral Health Virtual Instruction through video conference
 - Behavioral Health Virtual Instruction through telephone conference
 - Printed lessons provided by LearnWell and administered by hospital staff

Behavioral Health Virtual Instruction Overview



- LearnWell teachers provide up to 60 minutes of group instruction per day through BlueJeans (videoconferencing tool) or teleconference to students at a pre-determined time.
- LearnWell teachers deliver a 3-tier lesson to the students, aligned to common core standards.
- Hospital point of contact provides on-site classroom management and student materials.
- LearnWell will connect with student's district for approval of services and the student's schoolwork and continue to deliver session reports for approved students. The hospital staff will collect completed schoolwork to submit to LearnWell.
- Maximum of 12 students per session.

BlueJeans Interface



- HIPAA compliant
- No download required
- Browser-based
(Recommend 1.5 Mbps internet speed)
- Live video with teacher
- Screenshare capabilities
- Whiteboard compatible



LearnWell will provide:

- 60 minutes of group instruction per day with the same LearnWell teacher that has been supporting your site (when available).
- BlueJeans videoconference platform.
- Common Core lessons in ELA, math, science and social studies; and will work to obtain students individual schoolwork from their home district, if approved.
- Chromebook with camera (where needed, and pending availability).
- Special accommodations for 1-on-1 support, as occasionally needed.
- Communication with the hospital staff before, during and/or after each lesson as necessary in order to support smooth delivery of services.



Hospital Requirements

- Fax or scan/email student referral paperwork and parent consent forms daily (enables LearnWell to receive funding and schoolwork from districts).
- Send daily census to LearnWell before scheduled class time.
- Classroom supervision during the lessons; including taking attendance as well as the provision and collection of materials including paper, pencils, etc. (Written work completed by students will need to be collected and filed so that students may receive district credit for class participation).
- Access to internet connection and telephone line.
- Daily set-up and log in to the BlueJeans browser-based meeting room or dialing into a conference line.
- Printing of lesson materials (at hospital discretion) provided by LearnWell.



Getting Started

- Your LearnWell Regional Director and Classroom teacher will work with your staff to complete the following:
 - Assess your current technology needs
 - Discuss logistics of managing the program together
 - Schedule your ongoing instruction time



Summary of Available Services

- Group Behavioral Health Virtual Teaching Instruction via video conference or telephone
 - Up to 60-minutes of instruction per day
 - Communication with district schoolwork (where possible)
 - No cost to the hospital for period of time (discuss with LearnWell representative)
- Printed Lesson Materials Support
 - Daily lessons emailed to the hospital for hospital staff to administer as appropriate
 - No cost to the hospital
- Specialized 1:1 Virtual Teaching
 - Individualized lessons for students provided in 30-minute sessions
 - \$25 per half hour; billable to hospital or patient's family (sold in 10-hour blocks)
